

## Power Reviews - Submission Terms

These Submission Terms apply to your submission of ratings, reviews, comments, photos, videos, questions and answers, and other user-generated content associated with an assessment of our products or services ("Review") purchased from us ("THOMAS SABO") for which you are submitting the Review. You may submit a Review to THOMAS SABO who contacts you about a purchase. These Submission Terms are supplemental to and incorporated by reference into any online terms and conditions located on our website(s) when you submit your Review ("General Terms"). To the extent that any provisions of these Submission Terms are inconsistent with the terms of the General Terms, the terms these of Submission Terms shall govern.

**Privacy:** The collection and use of personal information in connection with your Reviews(s) are described in the posted privacy policy on the website(s) through which you submit your Review.

**How to Submit Review:** In order to submit a Review, you may be asked to create an account by THOMAS SABO, or otherwise asked to submit information, such as your name, email address, and other information about you and your personal experience.

### Who May Post:

- You may submit a Review if you have had a personal experience with THOMAS SABO's product or service. Please do not submit a Review if you have yet to make a purchase or have no experience with the specific product or service or with THOMAS SABO.
- You may not use a false e-mail address, impersonate any person or entity, or otherwise mislead THOMAS SABO or others as to the origin of any Review.
- Your Review should be objective and unbiased.
- **PLEASE NOTE:** If you have any affiliation with THOMAS SABO, a Loyalty Administrator (if applicable), PowerReviews, or any other relevant party, you **must** clearly disclose that, in plain language, at or near the beginning of your comments. This includes:
  - Any situation in which you've received anything of value from THOMAS SABO, a Loyalty Administrator, PowerReviews or any other relevant party – such as free or discounted products or services, money, a sweepstakes entry, loyalty points, access to events, or coupons – in exchange for writing the review.
  - If you work for (or own) THOMAS SABO, a Loyalty Administrator, PowerReviews, or any other relevant party.

### Your Review Must Be:

1. **Relevant.** Your Review should only concern your experience with a product or service you purchased, and should not include irrelevant comparisons or references to websites, hyperlinks, URLs, etc. that are not associated with THOMAS SABO's website(s). This form is only a forum to evaluate your experience about a product or service you have purchased; if you have a request about your order, please contact THOMAS SABO's customer support.

2. **Honest and Accurate.** Your Review should be honest about who you are and what you have experienced, whether positive or negative, and you should state your opinion truthfully and accurately.
3. **Original and Solely Written by You.** You must write the review entirely yourself. It must be original to you and not written with the help of any person or technology.

***Your Review Must Not Include:***

1. **False or Misleading Content.** Do not post any content that is false, fraudulent, defamatory, libelous, or otherwise untruthful.
2. **Profane or Obscene Content.** Do not post content that is profane, obscene, offensive, illicit, or otherwise inappropriate, including content that is pornographic or otherwise adult-oriented or sexually explicit or indecent. 5. **Advertising Content.** Do not post content that advertises or promotes another product or service or any kind of commercial solicitation, including as a way to raise money.

**License to Use Review:** You remain the owner of your Review, but you acknowledge that THOMAS SABO must have a license from you in order to accept your Review. Accordingly, you grant to THOMAS SABO and any parent, subsidiaries, affiliates, suppliers, vendors, and service providers (including but not limited to PowerReviews, Inc., collectively, the “**Licensees**”) an unrestricted, worldwide, irrevocable, perpetual, transferable and royalty-free license (but not
